

Q1 Progress Report

This is a progress report covering the first quarter of 2017-18 (1 April 2017- 30 June 2017).

1. Governance

1.1. HPE Steering Committee (HPESC)

The HPESC met on the 9 June 2017 at Central Hall Westminster.

2. Campaign

2.1. Spring prevention campaign

Q1 is a quiet quarter, in between Spring and Summer campaigns. Spring prevention activity carried on until May.

The condom quiz tool and trial pack scheme continued to be promoted on social media, along with the Treatment as Prevention (TasP) video produced.

By the end of Q1, the video had a reach of 289,725; was viewed 245,712 times; and was watched to at least 75% by 50,000.

The condom quiz was used 7,848 times and 1,854 condom trial packs were ordered, representing a 23.6% conversion rate.

3. Local Activation

Local activity was minimal over Q1. LAPS finalised delivery of spring activity, and in Q1 delivered:

- 65 MSM one-to-ones
- 268 MSM tests
- 2, 232 black African one-to-ones

• 85 black African tests

HPE did not start purchasing activity until Q3, and therefore purchased activity for 2016-17 did not cover the busy summer months during 2016. Purchasing for 2017-18 will cover Summer 2017 and *National HIV Testing Week* 2017 with any remaining budget for Q4.

4. Stakeholder Leadership
